



## Owner Liability and Health Certification

### Owner Agreement

I, \_\_\_\_\_, hereby certify that my dog(s): \_\_\_\_\_ is/are in good health and has/have not been ill with any communicable condition in the last 30 days. I further certify that my dog(s) has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog. I have read and understand the following:

1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending The Crate Escape.
2. I further understand and agree that in admitting my dog(s) to The Crate Escape, The Crate Escape staff have relied on my representation that my dog(s) is/are in good health and has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog.
3. I further understand and agree that The Crate Escape and their staff/volunteers will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog(s) attendance and participation at The Crate Escape.
4. I further understand and agree that dogs can sometimes receive minor cuts and scratches at daycare and any problems that develop will be treated as deemed best by staff and volunteers at The Crate Escape, at their sole discretion, and I assume full financial responsibility for any and all expenses involved.
5. I further understand and agree that all dogs of appropriate age must be current on their Rabies, Distemper and Bordetella vaccines. Failure to stay current on these vaccines will result in termination of daycare until the vaccines are updated. All dogs of six months of age must be spayed/neutered. Failure to spay/neuter by six months will result in termination of daycare. I also understand that the staff of The Crate Escape do everything within their power to prevent contagious viruses from spreading from dog to dog, however, it is still possible that my dog(s) may contract a virus. I assume full financial responsibility for any and all expenses involved.
6. I further understand and agree that the staff and volunteers of The Crate Escape ensure the use of full precaution while my dog(s) are on trail walks. A properly fitted collar and leash must be provided in order for my dog(s) to participate on the trail walk. In the event of my dog(s) escaping from the trail walk, I release any fault or responsibility from the staff and volunteers at The Crate Escape.

7. In addition, I understand and agree that it is the owner(s) responsibility to ensure their dog(s) is treated for fleas, ticks, lice, etc. The Crate Escape will not be held liable for any possible contraction of fleas, ticks, lice, etc.

I have read the following and understand the conditions, and statements of this agreement, including the following:

**FEES:** Fees are based on a day to day basis or package plan. Puppy packages are valid until six months of age. Adult packages are valid for twelve months from date of purchase.

**DAYS AND HOURS:** Monday through Friday from 7:00am until 7:00pm. Saturday from 9:00am until 5:00pm. The Crate Escape is not an overnight facility. Staff goes off duty Monday through Friday at 7:00pm and Saturday at 5:00pm. There is a \$1.00 per minute charge for any pet left after closing time. These hours are subject to change at the discretion of The Crate Escape staff.

**RESERVATIONS:** Required. Reserved daycare dogs will be served first. If at capacity, walk in's will be turned away.
